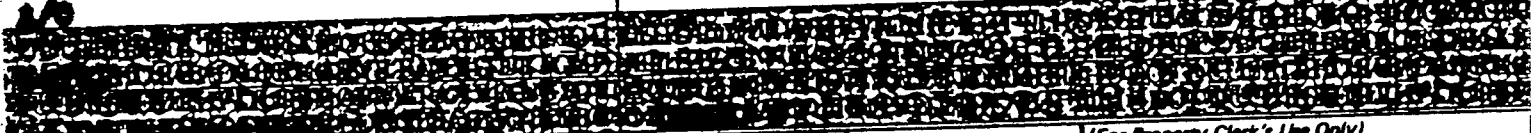

At 11:45 AM August 25, 1977, the undersigned officers along with Henry Ulrich, Nat Berkowitz, Ira J. Jultak and a carpenter hired by Nat Berkowitz proceeded to 35 Pine St. apartment 7E, where the undersigned turned over the keys to the above apartment.

It should be noted that prior to entering the apartment, the door was secured by lock and evidence tape, and all windows were secured by lock.

Further that at the above time, the Yonkers Police Department, was released from any security at apartment 7E 35 Pine Street.
