Result of examination:

Specimens Qc1 through Qc4 were searched through the appropriate sections of the Anonymous Letter File without effecting an identification. Appropriate photographs will be added.

Because of the lack of an adequate amount of known hand printing and an absence of comparable handwriting prepared by DAVID R. BERKOWITZ, Kc1, a definite conclusion was not reached whether the questioned entries on specimens Qc1 through Qc4 were or were not prepared by this person. However, as could be determined from the available writings, characteristics were noted in a portion of the hand printed address on Qc2 which indicate that dictated handwriting and hand printing prepared by BERKOWITZ in the same wording of the questioned writings on items in this case should be obtained. The writers should not be permitted to view the questioned material.

If a future examination is desired, efforts should be made to obtain the original documents of Qc1 through Qc4.

The submitted evidence has been photographed. These items are returned herewith.

This letter is to inform you that I am in the process of filing legal papers in Yorkers City Court to have one of your dogs removed from your property because he is a public nuisance. I have already spoken to the people of the humane society of Westchester and they agree with my actions.

You're probably thinking that I am some kind of animal hater or I'm a cruel person but that isn't true. Let me tell you that I love animals very much. However, one of your dogs, and you know which one, is obviously very sick or is being treated badly. He howls and barks constantly for hours at a time and there is no reason for it. If he's sick, take him to a vet. If he cannot be left alone then don't leave him alone. ~~But~~ And if its because you mistreat him then maybe its best you just give him up.

When my wife and I set up our

home in Yonkers we wanted to live our lives in peace and happiness. Unfortunately your dog has prevented us from doing so. Our lives have been torn apart because of this dog. We can't sleep late in the day, we can't come home in the evening and relax, and we cannot keep our windows open at all. Even with our windows and storm windows closed, to include heavy drapes, the howling is so loud and constant that these barriers cannot keep the sound out. It's as if he were in the house with us.

In the past week, for example, we tried to arrange our work schedules so we could have a few days off together. We wanted to spend some quite weekdays, just the two of us, to sleep late, to make love, to read, etc., but the barking and howling continued and we had no peace. Today is Easter Sunday, I'm writing this letter now and as usual the dog has been going at it for the entire day - unbelievable!<sup>10</sup>

- A. The Landlord agrees to paint apartment in accordance with the Pine Hill Building Standards.
- B. The Landlord shall prepare and mail or otherwise deliver to the Tenant, written leases which shall be in the same basic form as are leases for other apartments in Pine Hill.
- C. The Tenant shall within one (1) week after the receipt of said lease, execute all copies and return same to the Landlord along with the balance of the first months rent and the security; otherwise, at the Landlord's option, the lease will not be executed on its part.
- D. If Tenant's references are not satisfactory to Landlord, Landlord may refund the amount received from Tenant, less cost for credit report and preparation of lease, and all liability of both parties hereunder shall cease. In the event of misrepresentation or refusal to furnish credit information by Tenant, or if Tenant attempts to cancel the binder, or fails or refuses to return the leases as provided herein, the total deposit shall be forfeited.
- E. If for any reason Landlord shall be unable to give possession at commencement of the term, Landlord shall not be liable therefor, but Tenant shall be credited upon the next rent to become due with a deduction proportionate to the period for which possession could not be given. In all events, the termination date shall remain as provided in the lease.
- F. Except for the kitchen, bathroom(s) and dining area, Tenant must carpet balance of apartment within thirty (30) days of occupancy.
- G. Landlord or Landlord's agents have made no representation or promises with respect to the premises except those contained herein and Landlord will not make any unusual decorations or alterations to the premises except those expressly set forth herein. This instrument may not be changed orally.
- H. All applications are subject to final approval of the Landlord.

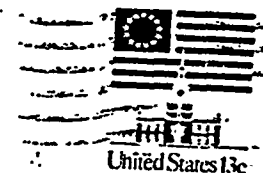
