Said summonses were issued on NY Registration 561XLB which is the auto owned by David Berkowitz of 35 Pine Street. Summons #YB899036 was issued on May 31st, 1977 at 7:15AM at 35 Pine Street for No Parking and summons #YB783615 was issued on September 17, 1976 at 2:40AM opposite 35 Pine Street for No Parking Zone.

The undersigned officer then contacted Lt. Faverau of the Traffic Court and he related that both of these summonses were paid by check; summons #899036 paid on June 7th, 1977 and summons 783615 paid on October 4th, 1976 by check.

In further questioning him, in regards to possible copies of the checks paid by Berkowitz, Lt. Faverau stated that upon receiving the checks, from Berkowitz or anyone else paying a traffic violation in a similar manner, said check is then sent to the bank, deposited in a city account and the check is returned to the complainant, and at no time, does the City make any type of photostatic copies or have copies of said check.
