The undersigned officer then contacted Lt. Faverau of the Traffic Court and he related that both of these summonses were paid by check; summons #899036 paid on June 7th, 1977 and summons 783615 paid on October 4th, 1976 by check..

In further questioning him, in regards to possible copies of the checks paid by Berkowitz, Lt. Faverau stated that upon receiving the checks, from Berkowitz or anyone else paying a traffic violation in a similar manner, said check is then sent to the bank, deposited in a city account and the check is returned to the complainant, and at no time, does the City make any type of photostatic copies or have copies of said check.
