Assigned this date proceeded to Address regarding a dog shot on December 24, 1976, at approximately 11:00 PM.

Upon arrival to said location, assigned spoke with Joaquin Neto, Race & Gender years of age, who stated that on the above date, he was in fact having a party in his home when at approximately 11:00PM, he heard what appeared to be a gunshot outside his front door. At this time, Mr. Neto and other family members proceeded to the front of the house where they observed their German Shepherd dog lying on a stoop on the right side of the house, at which time, Mr. Neto observed dog bleeding.

Investigation by assigned revealed dog had apparently been shot from north side of the street, whereas said bullet penetrated the a chainlink fence hitting said dog and going through same.

Further investigation revealed that after said bullet passed through said dog, same had bounced off a wooden step in an unknown direction. Assigned further observed that two bullets had penetrated the alluminum siding just above where said German Shepherd had been shot. An attempt by assigned officers to retrieve said bullets, proved negative at this date due to the fact that Mr. Neto did not wish assigned officers to pry open alluminum siding in order to obtain said bullets.

Mr. Neto stated that he would in fact notify the contractor who had placed alluminum siding on said building in the AM in order for him to dislocate alluminum siding from building without damaging same. Assigned to proceed to Mr. Neto's house on December 29th after said siding has been removed in order to obtain said bullets.



Mrs. Neto related that a couple of weeks after the arson of her house which occurred on May 13, 1976, a letter addressed to her was intercepted by her mother Andria Almeida, which her sister Sylvia Estebanez of Address read same without the knowledge of Mrs. Neto. This letter expressed hate for the Neto family and further that the dogs of hell and the Neto family had to be destroyed. This letter was not signed and it was immediately destroyed by Mrs. Neto's mother and sister. Mrs. Neto was not informed of this letter at that time because she was suffering from a nervous condition. The Police Department was not notified of this letter.

Mrs. Neto stated that at no time did she receive any other letters nor did she receive any threatening telephone calls.
