On the above time and date, the assigned received information that the carcasses of three dead dogs were buried in a lot south of 35 Pine Street, and that a possibility exists that these three animals may have been shot by David Berkowitz sometime during the past few months.

The assigned, along with Det. Sgt. Christopher, proceeded to this location and thereat met with the Emergency Squad Officers T. McGrath and R. Prendergast. Officer McGrath informed the assigned that on August 11, 1977, a shallow grave site was discovered in which the carcasses of three animals were found. Officer McGrath then led the assigned along with two men from the Department of Public Works to this area. The men from the Department of Public Works began shoveling at this location and found at this location in approximately five to six inches of earch which was soft, recently dug earth, were the carcasses of three apparently dead dogs. The bones of same were placed in plastic bags and placed in Radio Car #604.

While at this location, the assigned spoke to the following youths: One 10 years old, male white, of reduces phone number The youth stated to the assigned that approximately five and a half months ago while he and his buddy Dane were walking around in this lot south of 35 Pine Street, they found in one location two dead shepherd dogs; both dogs to him appeared to have been strangled or choked in some manner. Then approximately 100 yards away at the southwest end of 35 Pine Street, another shepherd was found with a hole in his head which might have been caused by possibly a bullet wound.

The assigned was further informed by this youth that he and his buddy collected all three dogs and they had taken the dogs over to their club site which was the location where they were dug up by the D.P.W. men and that he and his buddy Dane buried these dogs in the shallow grave there and did not say anything to anyone, as no one in the neighborhood had complained about the dogs being missing. The youth could give no further information concerning these dogs, nor how the dogs, or who had destroyed these animals.
