I have used the Minot online records request system to request a copy of ALL records in the possession, custody or control of the Minot Police Department, including but not limited to its investigatory units, and past or present officials of the Minot Police Department, of:

- ALL investigative activities and reports regarding murders committed between 1976 and 1977 by David Berkowitz (a/k/a Son of Sam), as well as, investigative activities of any possible North Dakota co-conspirators for murder. This request includes, but is not limited to, correspondence with law enforcement agencies and/or district attorneys' offices outside the city of Minot (including Westchester County New York, the City of Yonkers, NY, and New York City, NY), regarding the investigation, arrest and prosecution of David Berkowitz, or possible co-conspirators in North Dakota.
- ALL investigative activities and reports regarding the death of John C. Carr (DOB: 10/12/1946), a death that occurred on Minot Air Force Base on or about 02/17/1978. Mr. Carr was a Yonkers, NY resident, who was known to be a member of a satanic cult group, and a neighbor and acquaintance of David Berkowitz.
