Apartment found to contain shotgun and small caliber rifle, plus ammo and other written matter.

Deft. transported to One Police Plaza where he was interviewed by ADA Aiello and representatives of the Bronx and Queens D.A.'s office.

After rights deft. gave a full confession as to the killing of Stacey Moskowitz and the wounding of Robert Violante. He admitted the .44 cal. revolver found in his car was the murder weapon and that he bought same in May or June of 1976 in Houston, Texas.

Deft. states as his motive that he is ordered to kill by Sam Carr, who is his master.

Deft. apparently picked his victims at random after getting his "orders" from Sam.

Deft. drove a 1974 Ford Galaxie, registered in his name, to and from the scene of this crime, as well as, the others listed below.

When questioned by members of the Queens D.A.'s office deft. admitted to shooting incidents in that County on Oct. 23, 1976, Nov. 27, 1976, Jan. 30, 1977 and March 8, 1977.

When questioned by an ADA from the Bronx deft. admitted to similar incidents there on July 29, 1976 and April 17, 1977.

Deft. to be booked this a.m. in Brooklyn by Detectives Zego and Falotico of the 10th HZ and charged to Murder 2°, Att. Mur. 2°, assault 1° and Criminal Possession Weapon 2°.

Since original phone call from of (M.O.P. Motorized Observational Patrol, I have received several other messages indicating that Mr. has more information re: Berkowitz case.

On 8/17/77, I spoke to Sgt. Gallagher of 100th Pct. who informed me that he is familiar with M.O.P. as it functions out of 100th Pct. and does work under supervision of Capt. Gormano. Sgt. Gallagher further stated that Mr. does not have a reputation for reliability or credibility. Rather, Mr. has claimed in the past to have close connections with Federal, State and City law enforcement as an undercover agent and has volunteered numerous leads and solutions to the .44 caliber case throughout this investigation. He is frequently at or in vicinity of the 100th Pct. and tends to be an annoyance to the Police department working there.

For the above reasons, it is my opinion that Mr. is not a reliable person for the purposes of this investigation.
