Deft. arrested in his car outside his home in Yonkers by detectives from 10th Hom. Zone and other New York City Police Officers. Deft's car given a parking ticket on morning of 7/31/77 in vicinity of shooting and thereafter traced to him in Yonkers, Westchester County. Search warrant obtained for car and deft's apartment. .44 cal. Charter Arms Bulldog Revolver found in car, as well as, .45 cal. machine gun and a note to Suffolk County Sheriff. .44 cal. revolver apparently matches that used in this homicide.

Apartment found to contain shotgun and small caliber rifle, plus ammo and other written matter.

Deft. transported to One Police Plaza where he was interviewed by ADA Aiello and representatives of the Bronx and Queens D.A.'s office.

After rights deft. gave a full confession as to the killing of Stacey Moskowitz and the wounding of Robert Violante. He admitted the .44 cal. revolver found in his car was the murder weapon and that he bought same in May or June of 1976 in Houston, Texas.

Deft. states as his motive that he is ordered to kill by Sam Carr, who is his master.

Deft. apparently picked his victims at random after getting his "orders" from Sam.

Deft. drove a 1974 Ford Galaxie, registered in his name, to and from the scene of this crime, as well as, the others listed below.

When questioned by members of the Queens D.A.'s office deft. admitted to shooting incidents in that County on Oct. 23, 1976, Nov. 27, 1976, Jan. 30, 1977 and March 8, 1977.

When questioned by an ADA from the Bronx deft. admitted to similar incidents there on July 29, 1976 and April 17, 1977.

Deft. to be booked this a.m. in Brooklyn by Detectives Zego and Falotico of the 10th HZ and charged to Murder 2<sup>o</sup>, Att. Mur. 2<sup>o</sup>, assault 1<sup>o</sup> and Criminal Possession Weapon 2<sup>o</sup>.

[REDACTED] has access to 3 or 4 cars. After breaking up, [REDACTED] lost 30 lbs. and his weight has fluctuated since. [REDACTED] now has shorter hair than the photo.

About one month ago, [REDACTED] and [REDACTED] began to live together and this is on Shore Parkway.

About 2 months ago [REDACTED] knifed [REDACTED] and her male companion in Staten Island and this case is pending.

Spoke with Insp. Dowd - Mr. [REDACTED] referred to him. They will investigate.

Received no further info. by the writing of this report.

Per news media - witness named "Carol" heard a shot as she drank coffee with girlfriend. Called 911 to report shooting. Other witnesses names unknown to me, may have seen perpetrator. Identified as M/W/25, blue jeans and white tee shirt.

Advised Deputy Chief Fogelson and subsequently received a request for info. from ADA Rosen.

ADA Callan went to Houston, Tex. to speak with witnesses. Trace origin of .44 Bulldog Revolver used in "Son of Sam" killings.

Witness #1 [REDACTED] is an old army buddy of David Berkowitz. First met Berkowitz at Fort Polk, LA and was later stationed with defendant in Korea. On June 11, 1976 defendant paid witness a surprise visit in Houston. Defendant told witness that he needed a gun for protection. Defendant stated that he intended to travel around the country and would be carrying a lot of money. On June 12, 1976 witness and defendant went to the Spring Branch Jewelry and Loan at [REDACTED] and purchased a charter arms .44 bulldog revolver bearing serial #212927 and 2 boxes of ammunition. Money for the transaction was supplied by Berkowitz. Berkowitz left Houston with the gun on the following day June 13, 1976.

Witness identified his signature on a federal firearms form and a receipt. Both receipts were signed at the time the gun was purchased. Copies of the receipts have been turned over to 1st. ADA Greenberg. The originals are in the files of the Bureau of Alcohol, Tobacco and Firearms in Houston.

Present during the tape recorded interview with witness were witness's attorneys Ralph and Johnnie Abercia of Houston, Tex. and witness's girlfriend [REDACTED] of [REDACTED], [REDACTED] ) A.T.F. agent Jim Collins entered the room briefly and exited the room during the interview.

Tape of interview given to 1st ADA Greenberg by ADA Callan.

Witness #2 [REDACTED] is manager of Spring Branch Jewelry and Loan of [REDACTED].

Witness has no specific recollection of either [REDACTED] or defendant.

By examining his records he was able to ascertain that he sold a .44 bulldog revolver bearing serial # 212927 and 2 boxes of ammunition to one [REDACTED] on June 12, 1976. The gun had been purchased on June 1, 1974 from an wholesaler, Dave's House of Guns [REDACTED] (invoice #018319)

Witness previously gave a sworn statement to Special Agent Charles J. McClelland of A.T.F. (attached.)

Witness #3 W. Rothget is A.T.F. agent in charge of "Son of Sam" investigation in Houston. He has custody of all receipts and forms pertaining to the .44. He will produce these documents at the Berkowitz Trial. A.T.F. will also locate and notify any Houston, witnesses necessary for the trial.

Witness #1 [REDACTED] was sworn, he stated he had knowledge concerning a possible suspect who is currently referred to as the .44 killer or Son of Sam. His knowledge was transmitted to Det. Gallagher of the Homicide Task Force prior to Stacey Moskowitz death on 7/29/77.

Witness #1 [REDACTED] claims a person he knows a [REDACTED] [REDACTED] Road, North Merrick fitted the profile released of the Son of Sam. [REDACTED] was fitted by a girl with long hair (dark), drove a Yellow Dodge Aspen, fitted the composite released by the N.Y.P.D., and lived alone with his mother. On the Monday, before 7/29/77 (7/25/77) witness #1 [REDACTED] was with [REDACTED] and others at a bar. Another friend of the witness #1 [REDACTED] said to [REDACTED] you look like the .44 caliber killer. [REDACTED] replied "you shouldn't malign someone's personality." [REDACTED] was asked if he owned a .44 caliber and replied he doesn't have it anymore.

Witness #1 [REDACTED] went to the place of occurrence sometime after 7/31/77 with a friend, and he started to develop a theory of how the killer could have escaped after the shooting.

Witness #1 [REDACTED] saw [REDACTED] after the killing and eventual arrest of Berkowitz but [REDACTED] and he had nothing more than a general conversation about the case.

Witness #1 [REDACTED] at this time, does not believe [REDACTED] to be the .44 killer or associated with him.

Witness #1 is a 1st year law student at Yeshiva U. and is a "junior detective."

Mr. [REDACTED] would not elaborate over telephone reporting his sources of information on the identify of defendant's friend, but stated it was his belief based on his private investigation that defendant was not alone in his killing spree but was assisted by his friend. Furthermore, Mr. [REDACTED] stated he had information linking defendant's friend to Moskowitz homicide in Bensonhurst on 7/31/77.

Mr. [REDACTED] information will be investigated further on 8/16/77.

Since original phone call from [REDACTED] of (M.O.P. Motorized Observational Patrol, I have received several other messages indicating that Mr. [REDACTED] has more information re: Berkowitz case.

On 8/17/77, I spoke to Sgt. Gallagher of 100th Pct. who informed me that he is familiar with M.O.P. as it functions out of 100th Pct. and does work under supervision of Capt. Gormano. Sgt. Gallagher further stated that Mr. [REDACTED] does not have a reputation for reliability or credibility. Rather, Mr. [REDACTED] has claimed in the past to have close connections with Federal, State and City law enforcement as an undercover agent and has volunteered numerous leads and solutions to the .44 caliber case throughout this investigation. He is frequently at or in vicinity of the 100th Pct. and tends to be an annoyance to the Police department working there.

For the above reasons, it is my opinion that Mr. [REDACTED] is not a reliable person for the purposes of this investigation.
