Hundreds of tenants of the Ocean Village apartment complex in Arverne, many of them elderly, were without lights and water for more than 18 hours yesterday after a short circuit in an electric metering system knocked out power throughout the development.

A spokesman for the Long Island Lighting Co. said the short circuit, as yet unexplained, occurred at about 10:30 p.m. Saturday and burned out all power lines into the 11-building high-rise complex between Beach 56th and Beach 59th Sts.

The failure stalled the development's water pumping system and stopped elevators, trapping tenants in the upper reaches of the buildings.

"Everything went out last

"Everything went out last night, but this morning I had to find out how critical the situation was." said Harry Hirsch, 70, a retired news photographer of the old Mirror who lives on the 17th floor of a building at 57-15 Shore Front Parkway. "There are no windows on the stairways, so I had to make my way down using matches: It wasn't easy. I had to rest after every flight."

Hirsch, recuperating from open heart surgery, spent the day in the lobby of his building with about a dozen other tenants who braved the trip from their apartments in the 19-story building.

"I finally had to come down this afternoon because I had no water to wash with or drink, but I know there are a lot of people still up there," said Joseph Nocera, 58, who lives on the 15th floor. "I came down by candle, but I'm certainly not going up
