clear, cold, got there earliest ever: 10:50 in visit room. He's there 11:15. "You're earlier than usual." Dark yellow golf shirt, mustache returning, short haircut. Fifteen minutes on trip, chapel, light news and then he goes: "OK, what's up?" Straight business the rest of the way, with a 15- minute pause over lunch. Very clear DB sees what's going on and was serious and the most forthcoming ever in reply. Had about 25 items on list, got through all of them. Got so much, ran out of questions the last 10 minutes.

10 minutes. Los schongest times A-2. Great Togle - New Cos Legt 2 - Seeme quit must only 18 nearly togle - New Cos 1. Ace Brown. Confirms again and ID's photo. Says Ace was "a bit thinner when I knew him."

- 2. The "Whitey" mentioned 18 months ago by DB was in fact Ace's blond haired pal "Whitey." DB said he was "about 30." Said he was into dope and kids. DB said he didn't know Whitey's TN. When asked if Whitey may have been a car thief, too, DB said, "Sure, he might have been."
- 3. Did not know MW named "Lee" with dark hair that ran with Ace in '72.
- 4. Ace may not have known SOS was being done by the group in real time, but he sure knew after DB's arrest.
- 5. DB was at Ace's "a few times," along with the Carr brothers and possibly the cross-eyed sisters. "I think Ace probably knows them," he said. (This works with Marty Harding's comment on Ace around train station and the sisters there, too, he thought.) He said either Tommy Dorr or guy who looked just like Tommy Dorr was also at Ace's (he said this in Feb. visit also). DB said he didn't like to be around Ace too much because he was "so flamboyant." Suggested, with a laugh, that MT and Ace should have a date so MT could see for himself how flamboyant Ace was. When asked what they were doing at Ace's, he said "just hanging around."
- 6. DB said Ace would be up at the park now and then, "sex rituals, kids, drugs. Sex parties and kids. He knew it was cult stuff, he was "fringe" and not a member of the inner circle."
- 7. Said the Untermyer operation as "somewhat" JPD's meant "hard-core satanists, as well." He says he has every reason to suspect Process as "they were around then." (in late 60s early 1970s at Untermyer and in NY area.
- 8. Said for all he knew there could be bodies in "those old tunnels and catacombs that don't appear on plans." He again confirmed original site, too.
- 9. On Wahlstrom, said at the time Wheat would have been "on the fringes" at 15, and that Sperrazza, who was born in '47, was

- indeed in group before he was and "could have" been into it back that far. He didn't actually say Sperrazza was part of Wahlstrom case, however. Major interest in Wahlstrom continues strong.
- 10. Asked if it wasn't so that there was a pump house on west side of Van Cortlandt near Broadway. Said he knew of the NE pump house and said they went into the pipes "via a small hatch on that side. Yes, someone knew the ins and outs."
- 11. Judy Samuels. "Into the occult, somewhat a freelancer but may have been connected to OTO also." Said he didn't know about her and kid stuff.
- 12. "Pretty sure" he saw her and Howard S. together "once or twice at a party, maybe two parties." Said again, as far as he was told, a cousin or niece of Howard. He knew Judy from "clubs and parties." (I think he said he remembered her as being a pretty attractive woman).
- 13. On Mickey Rose (Jesse), DB was asked if he ever saw Judy and Mickey together. He replied: "I thought they were together"--- (meaning a couple, a relationship.) Said he believed Mickey was bisexual and Judy was also.
- 14. The "clubs" he recalled Mickey driving around to with the group were not the likes of Studio 54 and other glitter spots. DB said it was "the downtown clubs." He said he was referring to the S/M clubs like Vault, Mineshaft, Hellfire and that ilk. "There were a number of those clubs we went to," he said.
- 15. Ron Sisman: "He took photos of sex parties: orgies. There were parties with some rich people at them." (confirms Rich Wilson).
- 16. Said he was at Sisman's. Said it was on the west side around 23rd Street. He described it as being "about three stories in height" and tannish or light colored on outside with dark colored trim and perhaps black bannisters. Said he was no longer certain on a chandelier, but if it was said back in '81, it would have been accurate, to his knowledge.
- 17. Judy, Sisman and Mickey may have "crossed paths" or "brushed shoulders" in the clubs, as elements of same overall crowd. He couldn't recall any face-to-face close friendships between them.
- 18. Said in his day Sisman wasn't a big-time drug dealer, to his knowledge. Described him as being the kind "for small-time distribution, stuff for parties and that kind of thing."
- 19. Flat-out confirmed again that Sisman was at the Moskowitz scene. Said it was Sisman, DeVinko and Cummaro in the van, which he said "may have been rented or it may have been Dossenko's." He

- described the van as being "brownish or like rust-colored." (This matches Mrs. Davis).
- 20. Said Thomas Gurksnis was the "Tom" at the Moskowitz scene.
- 21. Knew "Phoenix" from Hamptons cult scene (per Fat Mary.) Did not recognize "Ceil". As for Phoenix, DB described her as "a young, rich woman who was a witch. TN "might be Sylvia; not sure." Did not know Crispo, Maplethorpe "could be; might be."
- 22. Said he was at one party in the Hamptons that was right on the ocean, very big house, with "about ten-to-twelve feet high bushes or hedges around it." He was at Radin's, but not sure if this particular house was Radin's or someone else's.
- 23. He asked who the girl was who was killed with Sisman. He was told college girl, around Rosyln Long Island. He then asked: "Amy?" Told it was Liz Platzman, he said he didn't know who she was. (This "Amy" brings back the "girl from LI" he discussed one time a year ago in relation to being on the Denaro scene.)
- 24. After a funny exchange, in which he didn't want to ID the person from the fish store in Yonkers who he had drinks with around New Main St. bars, he was asked, maybe 15 minutes later in a totally unrelated area of questioning: "Who was Angel Vasquez?" He smiled and replied: "That's the fish market guy I didn't want to get into. He's not guilty in this." MT said, "you know Angel has said he picked up hard drugs from your apartment a few times." DB said, "Awwww." MT laughed: "We're not after hard drugs, David, don't worry about that angle." (But Angel becomes a witness).
- 25. He knew "Claire" the beautiful blonde "black witch" from Van Cortlandt that was described in '94 to MT by POS, who got it from either Pettigano or Mike Teter (must check notes.)
- 26. Confirms parties at Roy Cohn's house. Said "people from Connecticut" at JPD's at start of SOS included "Process chapter from Connecticut people." Talked about some rich people involved with them, too. It wasn't clear if Cohn was at JPD's for that fateful meeting. Must be followed up. He spoke re: Hans LaVerge" of a "rich guy named Hans, Connecticut/Process tie, tall with white hair, who was like an outdoorsman-type. That look, that type," he saids. Not sure of last name. Said "photos would help in some of these instances."

- 27. One of those instances was Sam Nasr. Said name was not ringing a bell, but photo might do it.
- 28. Steve Verk: "yeah, he was pal of Cummaro's." DB said he knew Steve Verk and thought he may have been murdered a number of years ago. (R. Wilson, who put Verk with Cummaro, said he thought

also that Verk had died "several years ago." But Rich wasn't certain how.

- 29. Photo ID'd Bob Lowe as the guy who was with Mentzer when Mentzer came to NY for Freund and whatever else. Background: several months ago he was asked if "King Willie" had been alone in NY. DB said: "No, he had a somewhat husky guy with him who had a receding hairline." MT thought of Lowe, and showed DB today a newspaper photo array of four people (names removed). Lanie Jacobs, Lowe, Mentzer, and Alex LaMota Marti. DB was asked, if besides Mentzer, anyone looked familiar to him. He ID'd Lowe as being with Mentzer in NY.
- 30. He wasn't sure on Steve Storms, and not sure on Susan Storms. Wanted more info, like a photo, but none was available.
- 31. Eliminated Sam Halpert from E. Hampton (unless someone borrowed his car). Didn't know Ed McCarthy, either.
- 32. Eliminated Robt. Bronner; eliminated Robert Tompkins (though he asked for a photo here); eliminated the Conca brothers; said he didn't know Anthony Salveggi or Thomas Bolster.
- 33. On Peter and Michael Quinn (289 Warburton), he asked for photos asked if one was "a heavy guy, very weird?" MT said: "Very weird yes---heavy, I don't know." (Pix would help).
- 34. Didn't want to get into Judy's dad and any discussion of a fish store. Said "I don't know." Then: "I'm not sure." Here it was again, that sensitive area relating to "fishing boats" from January.
- 35. He knew about Lewis Harrison and "the vampire organization." But said he couldn't think of it's official name.
- 36. Said he thought the vampire teacher from Pleasantville was named "Reuben" or "Reubens." Asked if it could have been Peter Robins, he said, "not sure." (this could be a phone book switch or a LUDs error, or something).
- 37. Said he knew a guy named Hausman who ran a restaurant "Downtown", meaning in the relevant area. Couldn't recall his first name.
- 38. Speaking of which, he said he wanted to keep "crater face" out of it for now.
- 39. Knew a girlfriend of Wheat's known as "Ro" or "Roe." Said it may have been Gail Shebroe from DeHaven Drive. Pix would do it. Said he didn't think he knew Rayne Zeolla (that would be right, because by '75 she'd married and moved to Connecticut, per Mark Lundin info.)
