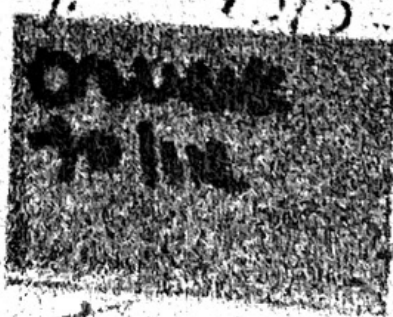

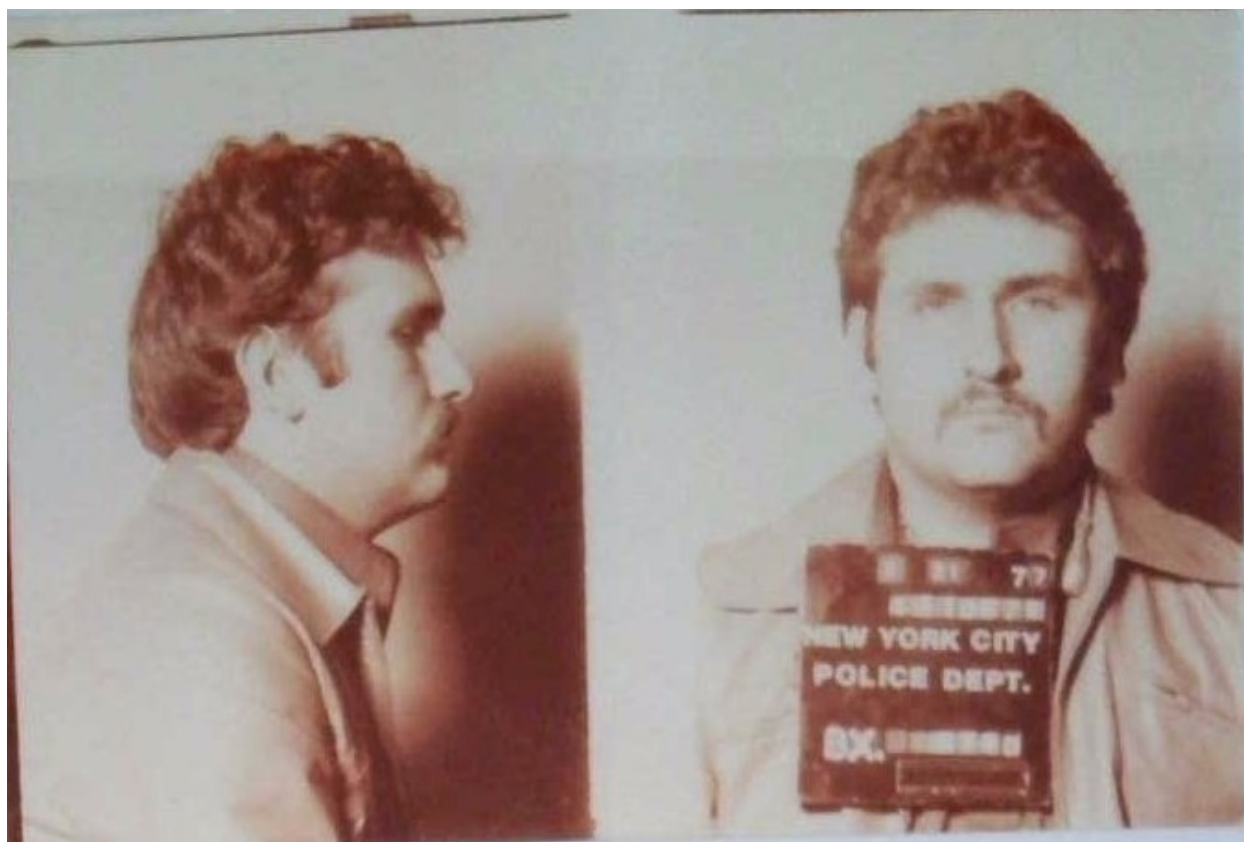

1. On June 5th, 1977 Detectives Joseph J Basteri and Herbert Murray interviewed Susan Jennings, F-W-24 years of 32-90 Campbell Drive, Bronx, NY (TA 2-0419) and she stated that she has known Donna Laurie and did on occasions associated with her. Susan stated that about five years ago Donna had received a friendship ring from a boy she only knew as Crazy Vinnie, (later identified as Vincent Minutolo of 1516 Station Avenue) and that Donna had returned the ring to him after about a year. This upset Vinnie very much. Susan heard that Vinnie had enrolled at St John's University in 1972. Susan then looked at the composite of the 44 killer and he stated that the sketch very much resembled Vinnie. Susan further stated that Vinnie was crazy enough to this type of act. Vinnie would constantly give Donna gifts.

2. Susan Jennings stated that she had lost trace of Donna and Vinnie until about two years ago went to meet Donna by chance. Susan asked Donna if she was still going with Vinnie and Donna remarked that she was not but he is still following her whenever she goes out on a date.

3. On June 13, 1977 Detective [redacted] and not with Ms [redacted] we would not be able to have access to these records to do so by Vincent Minutolo order or permission
