

ED SANDERS/MANSON MATTERS

---Immigration did investigation of Process; as did Frank Fowles (Inyo Cty. DA), who can still be reached today.

---Ed, 1/97. Smith of INS turned down when he wanted to start big investigation of Process. WHY???

---Cal. Attorney General also likely has Process data; as well as Santa Barbara cops (possibly Sheriff, too); San Jose PD, and perhaps Santa Clara Sheriff's Dept.

---Criminal Investigation Division of IRS also did investigation of Process. ED: St. Thomas, Process per your hardcover???

---Doris Tate on "no Helter Skelter as prime motive." Doris also confirms Sharon was supposed to stay at Sheilah Welles' place that night. How tipped off? (Garretson? Other? Dawson? Doyle?)

---Melcher's published comments on sex orgies at house; Sammy Davis' comments on satanism; Alex Saunders' ditto on Sharon and witchcraft.

---Charlene Cafritz data and other porn data, including Manson's letter re: top porn ring (kids/animals, etc.).

---Cafritz also talked about Manson being at a party at 10050 Cielo Dr. Alan Warnecke, pal of Melcher, said this also.

---Ed: copy of hardcover? All relevant Process stuff in it: more than just that one chapter. Other references, too.

---Ed: addresses of Process on Cornelia and E. 12 St. in Manhattan. Any/all Process files. Got Cornelia (28 and one-half).

---Mama Cass and Phillips subpoenaed. Why?

---1978 puff article on "Foundation" referenced in Dope, Inc.

---Find Danny DeCarlo, (Oregon around Medford?), linked to Process in Santa Barbara (per Sanders hardcover).

---Godard or Goddard (female) in Brooklyn. DeGs lived with her in 68-69 time frame.

---Find Victor Floyd Wild. SF State, Illinois dentistry school, I believe. DOB of 1940. "Leathers Limited" or Leathers Unlimited, formerly San Jose area, then around Goleta/Santa Barbara and later, per Ed Sanders, to Worster area of Massachusetts.

---Robert Hall? Know anything about him? Met DeG in England, SF State, Arch. Didn't Wild end up there, too, at dental school?

---Hall dated the daughter of Bronx congressman Jonathan Bingham

(64-82.) Her name: Claudia. Data from Ed S. and in INS report.

---Manson apparently wrecked Melcher's car. (Is this THE car?)

---Jack Ryan, Mattel, Barbie Doll, Navy big, missiles. Bel-Aire, coffins with freshly dead bodies. Ran covens, some cops knew about it.

TATE CASE PHONE LOGS

Below are the 10050 Cielo Drive phone calls pre-Tate murders. Roman Polanski was in London; Sharon returned from Europe July 20 (the day of the moon landing). Calls prior to then would have been made by Frykowski, Folger, or "guests" of theirs. The killings were Friday night August 8 (just after midnight August 9, technically). Of interest:

---July 7, 4:37 p.m., TORONTO. 416-787-6945. ('92 research found this was unlisted # belonging to a person named Schulbert, who said they had the number for 40 years.

---July 8, 8:51 p.m., TORONTO. Same number.

---July 8, 9:32 p.m., TORONTO. 416-487-7490. (Unknown).

(Note: Frykowski was dealing with Billy Doyle, etc., Canadian drug dealers out of Toronto, on distributing MDA. Process was also in Toronto, and Ben Rose was dealing with one "Jacques" Bouchard, also of Toronto, on LSD and other chemical dope).

---July 13, 6:09 p.m., BALACYNWYD, Penna. 215-664-7465. ('92 data: someone named LEASS, who said they had the # for 20 years. Close to '69 era, but not conclusive. The area code suggests this is in the greater Philadelphia area.

---July 13, 6:26 p.m., OCCOQUAN, Virginia. 703-491-3795. Out of service when checked in '92. This location isn't on MT's map, but the area code suggests it may be right near Annandale, just outside Alexandria. Annandale is where Harrison Pickens "Pic" Dawson sometimes stayed. Dawson, son of a state dept. official, was into drugs, and was a friend of Billy Doyle, Tom Harrigan, Charles Turcot, etc.---the drug dealers. Dawson had been arrested for drugs when disembarking a ship in London with Mama Cass in '67. When the word "Pig" was found in blood at the Tate house, some thought it was "Pic"---Dawson's nickname. Dawson had threatened Frykowski not long before the murders.

---July 13, 9:25 p.m., NYC. (after midnight in NY). 212-477-3988. '92 research found that in '69 this was an unpublished # that came back to the east side of Manhattan between 10th and 20th Sts. Also, when this # was phoned in '92, party answering

declined to give name but said they'd had # "for a long time."
 Note: Process was at Cornelia St. (off Bleecker in W. Village) and on East 12th St. in this '69 era. A Process "church" was on Cornelia St. at #11 and one-half or #12 and one half; and some Process members were living in a dwelling on E. 12th. Don't have the bldg. # yet. At this time, the DeGrimstons were staying in Brooklyn with someone (a woman I believe) named Godard or Goddard. Check via Crabtree/Phillips wife Goddard---Zodiac case.

---July 16, 6:28 a.m., NYC. 212-688-3154. This number in '69 belonged to an H.R. Jacobs, 345 E. 56 St. In '77, there was an H.R. Jacobs listed at 48 Greenwich Ave., and another H.R. Jacobs listed at 7 Lake St. in White Plains (an apt. bldg.).

---July 16, 6:39 a.m., Irving, Texas. 214-254-0744. No further info, but it's known from Helter Skelter that Frykowski and Folger had been in the Dallas area (specifically Irving) and made high level drug contacts there about six months prior to this call.

---July 16, 6:53 a.m., NYC. 212-982-4492. This number in '69 was listed to Brian Buckley, 315 E. 12 St., Manhattan. No other info on him, nor is it yet known if this was a Process residence, of which there was one somewhere on E. 12th. ('96 check lists just two Brian Buckley's around NY via computer run: one at 3104 Wilkinson Ave., Bronx. (Anthony Salveggi, mental patient who rented the DB room at the Cassara house either just after DB, lived at 3108 Wilkinson from 1960 til perhaps mid-70s.) It's right at Albert Einstein Medical Center/hospital area near Pelham Bay (Lauria/Suriani). There is also another Brian Buckley at 120 Burda Ave., New City (Rockland County).

---July 16, 6:55 a.m., Hartford, Ct. 203-523-0362. In '69 this # belonged to a Sol Weber, 325 N. Quaker Lane, West Hartford. When checked in '92, answering party stated they'd had the # "for fifty years," but wouldn't give a name. The only Sol Weber surfaced thus far in '77 book was a Sol Weber Insurance, Inc., located at 55 Northern Blvd., just over the Queens line in Nassau. Whether it's the same guy is unknown.

---July 19, 7:04 p.m. NYC. 212-688-3154. Another call to H.R. Jacobs, noted above.

---July 19, no time noted. NYC. 212-673-4747. In '69, this was a non-published # in the Stuyvesant Oval area (lower East Side). In '92, it had been disconnected and changed to 212-777-2024, and had been an office for about a year. As in the above number that came back to the lower East Side between 10th and 20th, we should note that St. Mark's Place, where Ben Rose maintained an apt., etc., falls in this grid, too.

---July 30, 3:07 p.m. Big Sur, Calif. 408-667-2335. This is

confirmed as then the # of the Esalen Institute in Big Sur, weird spot where DeGrimston had lectured---and where Manson would be on August 3 and Aug. 5. The call was likely made by Abigail Folger.

---August 1, 9:36 p.m. Dallas, Texas. 214-521-3977. No further info available, but may link to Frykowski drug dealing. (Recall later Mentzer arrest in Addison, northern Dallas suburb).

---August 6, at 3:47 and 3:57 p.m., Greenwich, Ct. 203-869-5522. This number in '69 was listed to Lewis A. Lapham, RR#2, Greenwich. In '77, Lewis A. Lapham was also listed with a NYC address at 36 E. 72 St. In '95, Lewis, Winston P. Latham and Andrew Lapham are listed at 19 E. 72 St. (Andrew Lapham is familiar, possibly show business?) Per Elvis, 5/31/96: Lewis A. Lapham Sr., now deceased, was a past president of Banker's Trust, and a biggie with Grace Lines (whoa---check Jim R. and Rich J. on Paul Luckenbach) and Hawaiian Steamship Co. Lewis A. Lapham, Jr. is a longtime editor of Harper's mag, and just the other week was at Phil Carlo's book party for his new "Night Stalker" book. (maybe coincidence). Folger's mother was in Ct. about this time, visiting friends after a Mediterranean cruise (Helter Skelter). Maybe this is where she was staying, maybe not.

AFTER THE MURDERS

---After the killings, on Sept. 3, a call was placed to Rochester NY, 200 Linden St. Number: 716-442-1958. Listed to a Charles F. Fox and Howard R. Lardner. (Not sure, but it's possible Lardner is "Ring" Lardner, Jr., son of the famed sportswriter and a reporter himself. In '95, there's a Charles F. Fox, DOB 2/43, at 527 Oak, #3 in Syracuse. Been there 12 yrs. SS#201-34-2576 (74?)

---After the murders, on Sept. 4 at 5:05 p.m. someone at 10050 Cielo called NYC, 212-874-3311. This was the number of Penelope Russianoff, Ph.D., who was at 315 W. 86 St. in '69, and still there in '77.

---On Sept. 5, at 1:05 p.m., a call was placed to NYC, 212-724-6693. No info re: '69, but was private answering service # in '92.

---Also at some point, not clear if before or post-murders (misplaced page) a call was placed to 212-742-6387. In '69 this was listed to "Limozn-By-Beeper" ("Spirit of NY cruises" part of note, also). The '69 address given for this Limozn-by-Beeper was in the NE Bronx, at 4360 Baychester Ave. This, of potential great interest, is right in the Wakefield section of the Bronx, near the corner of Baychester and 241 St.---and the Wakefield Car Svc. where Norman S. later worked in the '77 time period. It could even be the same place, for all we know now. It's also located near where Nickol lived, Carozza's pizza joint, Sperrazza was there at 707 E. 242 in '75, and its also near SOS victim Judy

Placido's home on Wickham Ave. This all may be coincidence: but maybe it isn't. Here's what it says now: a call was made right from 10050 Cielo Drive to a car service in what would later be a very relevant area of the NE Bronx in 75-77.

PROCESS DATA 6/3/96 (also see preceding notes)

1. Ed S. had heard of Chuck Hest; "might have been his car." Supports MR on "black car" wrecked by Manson post-murders.
2. Charlie's philosophy mirrors Process all the way, right to the use of Revelation, getting the fear, desert, "pit," etc.
3. Charlie and "multiple-devil worshippers" at Spiral Staircase, a private house located at the mouth end of Topanga Canyon Lane and behind "The Raft" restaurant, which was near or on the Coast Highway. The house was owned by a woman about 45 named Gina, whom Manson had met in SF and who was into heavy devil worship, etc. It was at the Spiral Staircase, Manson said, that he convened with "multiple-devil worshipping cult leaders." We know who worshipped multiple devils, don't we?
4. Patty K. and "blonde-haired Englishman" at Spiral Staircase. Krenwinkel ID'd DeGrimston to MT as being at that house.
5. Markham repping Leslie today.
6. Charlie letter to Ed S. on party at 10050 Cielo. He and DeGrimston there.
7. Charlie to Bugliosi on "Moor and I are one and the same." Process visits to Charlie and to Bugliosi and Manson article for Process Mag.
8. Alan Warnecke, pal of Terry Melcher, tells a reporter Charlie at was at a party at 10050. Charlene Cafritz said it also, per Ed Sanders. Question: during Melcher residency?
9. Dean Morehouse actually living at 10050 Cielo for short time in January '69, after Melcher leaves and before Sharon/Roman move in in February.
10. Charlie admits to Hard Copy he knew Sharon.
11. Charlie on "kid porn" and LaBianca/black book and Vegas card games.
12. In The Family, reference to 2-3 ex-con pals of Charlie visiting Spahn summer '69. Dope dealers, at least one was from Vegas.

13. August '69: Charlie at Esalen; Charlie acknowledges spending the night enroute with old friends "just outside" of Santa Barbara; and Sanders has Victor Floyd Wild (Brother Ely) in Goleta then---"just outside" Santa Barbara. Charlie says he left there with drugs enough to get the bikers off their backs and make kids at the Spahn ranch happy.

14. Krenwinkel, etc. getting buckskins sewn by Brother Ely at this shop.

15. Sources in "The Family" (from underground press stories, etc.) were obviously discussing Process.

16. Bruce Davis to England, Process contacts there. Sanders quotes "prominent LA homicide officer" on this. Sanders said Davis did a '94 interview, Bill Nelson has transcript, in which Davis said one purpose of his trip to England was "to heal the rift between Process and Scientology." Sanders says there are those who question this supposed rift---that it all may have been PR.

17. MR and Mill Valley data: Charlie/Process; Himalayan Academy. Sanders on Process/Manson north of SF in Mendocino? county. Manson at 636 Cole; Process at 407, in the Haight, same time. Manson w/Process; Himalayan Academy; San Anselmo at Timothy Leary's house.

18. DB on both Process people and Mentzer saying Manson "was in the group."

19. In his autobiography, *Why Me?*, Sammy Davis Jr. wrote of being at a mock-up black mass at a home in Beverly Hills at which one of the hooded leaders of the session was Jay Sebring. Davis also wrote that all of the Tate victims had at least dabbled in Satanism at one time or another. (Alex Saunders, head witch of Britain, also claimed he'd initiated Sharon Tate into witchcraft while she was filming in England, and said he had photos of her standing in a magic circle.) Doris Tate, Sharon's mother, told MT that a white cape was found at 10050 Cielo Drive and that Doris believed it was Abigail Folger's. It's also a fact that small, circular candle pots were arranged on the floor around Sharon's body and that books of matches were also found on that same area of the floor.

20. Here are the direct Davis, Jr. quotes: "The party was in a large, old house up in the hills and they were all wearing hoods or masks. They had a naked girl stretched out and chained to a red velvet altar. I played it cool. 'Hey, what's this?' 'We're satanists.'...One of the leaders of the group tilted his hood back to show me his face. It was a good friend of mine, Jay Sebring, my barber, who'd become famous in Hollywood. I'd always known Jay was a little weird. He had a dungeon in his house and

he'd say, 'You've got to come over, man, see what I've got downstairs. I've got some real antique pieces.'

Later, of the Tate crime scene, Davis, Jr. writes: "Everyone there had at one time or another been into Satanism, or, like myself, had dabbled around the edges of it for sexual kicks." Davis' daughter, Tracy, confirms he told her of his interest in satanism (interview on American Journal, aired in NY on 6/4/96. Elsewhere on 6/3/96.)

'86 notes from source MR: Bill "Knuckles" was a guiding light money source for Kenneth Anger. Knew Manson, too, and Shorty Shea and Folger.

Al Holbert: came to US from Israel, had a role in the Entebbe raid. Ed Sanders knew of Holbert, also, called him "Israeli intelligence" operative or stringer. Holbert involved in LA dope scene/LSD, etc.

---Others in chemical dope scene, prominent players at the time, were Ben Kalka and Marvin Kahn (sp?) and his wife, Margie, who ran Zig-Zag Bail Bonds in Los Angeles.

---Manson first exposed to Process in SF, via the Kenneth Anger crowd in the Haight, (Straight Theatre at corner of Cole and Haight). Process spoke, etc., and then Charlie involved on fringes of Himalayan Academy, an Anger/Leary enterprise at which Process also appeared.

---The home in Mill Valley (SF area) where Manson met Process was that of Bill and Hillel Resner. It was also accomplished at Timothy Leary's place in San Anselmo (also Bay area).

---Reggie Williams was involved with Process on coast then, too, and he knew Mentzer.

--- MR stated "Red-haired" Chuck (Chuckles) Hess, a big player in LSD, MDA. On coast in late '60s he was the middleman between the LSD labs and the Hell's Angels, who were doing the street distribution. He lived in Berkley in '68-'69. It may well have been his "big black car" Sanders wrote about that Manson was driving and crashed shortly after Tate-LaBianca. (Works with the LSD/chem. dope burn motive from several sources, including a couple in Manson's "family." MR said the car was a black Mercedes. Note: Sanders is aware of Hess, and says it "could have been his car." From MR, Hess's partner or sidekick in Cal. was named "Stevie." (Vallejo detective named Chuck Hess, and Steve Baldino a Vallejo cop who knew Darlene Ferrin very well.)

---Chuck Hess surfaces in NYC later. In fact, on Ace tape, JR asks Ace if he'd seen "Chuckie Hess" at Uncle Charlie's gay bar the preceding summer. Calif. Chuck Hess's middle name may be

Michael, Fed sheet, robbery at armory, Santa Cruz area.

---MR stated "Coke Light Pharmaceutical Corp." in England was a supplier of LSD. (Note may be somewhat incorrect on specific name, but it's close to that. Could be "Core-Light" too.)

---MR also stated that in late 60s Luther Green, whose mother was Dame Judith Anderson, "knew all about the scene."

---A black guy from NY known as "Baby James" also a player. He was a protege of James Brown.

---In "Papa John," his '86 book, John Philips agreed to editing out strong info. about Terry Melcher's heavy drug dealing.

--The following were S. California associates of Mentzer in the mid-80s, in addition to those arrested with him on the Radin/Mincher cases:

---Carl "Chuck" Plzak, 1272 N. Flores, West Hollywood.

---Kirk Killion, 1515 Pacific Ave., #205, Venice.

---William Brehm, 9618 Exposition Blvd. #115, LA.

---Roger Korban, 616 Marine St., Santa Monica. (Arthur tie?)

---Christopher Lynch, 5450 El Jardin, Long Beach.

(Then there's Alex LaMoti Marti, Bob Deremer, Bob Lowe, Mike Pascal, all in jail now), along with Mentzer. (Deremer may be out.)

---File notes confirm the Bobby Joe Horn (Mr. American Bandstand) case in '77 in which Mentzer is a top suspect (D.C. area) was Genovese-family related. (As was Johnny Stopps (Stoppelli), "Uncle Johnny" to Radin.) All this may tie in to Freund SOS in that it's Genovese or Gambino tie, which one to be determined. Vinny, in recent call, said "older Don" source on Freund motive was a "Pizza Connection" case guy.

Investigative avenues re Manson/Process. Cal. State Cops; archives in Sacramento. Santa Barbara cops and Santa Clara SO/San Jose PD. LAPD/LASO files.

---Kanab info: 9/96: from Utah cops: Process spent about 1.5 million in improvements alone to the Kanab ranch, and paid 500K to purchase Kirkland, Ariz. holdings.

---They have a "temple with stone pillars" at Kanab.

---Sealed off cave there, too, and aerial shots show round
