To whom it may concern:

I, David R. Berkowitz, hereby acknowledge that all of the following individuals either were involved---to one extent or another---in the so-called .44-caliber case, and/or, to one extent or another, were participants in the "social scene" populated by myself and others from mid-1975 until August, 1977.

I have already stated publicly, on television, that this overall organization included (but was not limited to) a cult group that met in Yonkers, the northeast Bronx, Van Cortlandt Park, Untermyer Park, and other locations. These other locations included the Purchase and South Salem areas of Westchester. I have already stated that the .44 shootings were the result of a conspiracy planned and carried out by members of this cult group, including myself. It is a true fact that relevant parts of this conspiracy originated in the city of Yonkers, N.Y.

In addition, this cult group interacted with other "friends and affiliates" in New York City, Long Island, Connecticut, and elsewhere---and these interactions included social activities like "parties." Also, for some, there were dealings in narcotics and illegal weapons, and dealings in illicit pornography and related activities, too. There is also reason to believe that members of this group, and its affiliates, were involved in other violent crimes, including homicides, in New York State and elsewhere in the continental U.S., including, but not limited to, the state of California. To my knowledge, which is hearsay, homicides connected to this organization occurred both before I became involved in this group in 1975, and after my arrest in August, 1977.

The exact nature of the roles these following individuals played in the operation is known by myself, by Mr. Maury Terry, and by another individual whose name cannot be mentioned here.

At this time, I am not yet in a position to proceed further than this: to verify that the names on this list are indeed relevant in various ways to the .44 case and, in some instances, to other cases, too. I have decided to take this limited step to ensure that a record is maintained and secured in the event of any unforeseen changes in my situation or that of Mr. Terry.

I represent that this list is true and accurate. It may not be totally complete, however, as there may be a few individuals whose names have not been included to this point. There also are other individuals whose identities were only known to me by nicknames they used. With that said, and with those qualifiers noted, the list appears on the following page.
