- On May 20, 2024, at approximately 1300 hrs, Det Grater and I met with [REDACTED] [REDACTED] and Retired Yonkers Detective at the Bronx Homicide Squad. The purpose of this meeting was to discuss the case and share relevant information.
- [REDACTED] is well versed in many aspects of the [REDACTED] pattern and has obtained various documents and conducted in-depth research. [REDACTED] position is that he is certain that [REDACTED] is the shooter in this case based on the sketch, MO and photo identifications made by the victim. He also cites a newspaper article which included reference to a [REDACTED] claim that he had shot a older woman that "crawled away".
- [REDACTED] states that as a result of his research, he is 99% certain that [REDACTED] is the shooter. He described his interview [REDACTED] as convincing and that the overall facts are compelling. He did raise questions regarding the husband of the victim and his possible links to organized crime. He also cited the attempts to Subpoena [REDACTED] in England prior to any police knowledge of SOS as possibly problematic and indicative of suspicion regarding the husband.

2. Ms.  originally from  England states she moved into the Bronx in 1963 after meeting her husband  at the  in Brussels where she worked as a performer. They married in 1967 and she lived as a housewife while her husband ran an insurance company and a detective agency. On the Date of incident, she received a call from her husband during the afternoon asking her to meet him for dinner since she was leaving to visit family in England the next day. Her husband had a meeting with the editor of a local newspaper at the  and she first met him there, driving herself to that location. she states that her husband suggested they get dinner at  which was her favorite restaurant. They drove separately and arrived together at  Her husband parked on street, and she parked in rear lot in back corner to protect her new car from being hit. She states they spent a few hours in  and interacted with owner,  aka  told her years later that a young man sat along wall and was staring at her but there was no further information or follow up.  knew every person in the place but did not know him. No arguments and no negative interactions occurred during dinner.

3. After dinner, they walked out of  using the front door. She states they turned left on Bouck, and that  is parked on Bouck just prior to Lot. She proceeded into corner of the lot and notices that the exact same Jaguar is parked next to her, and she shouts this to  He states, " get in the car and let's go" She states that she was supposed to follow him because his car was experiencing issues. She states that as she is putting her seatbelt on, she notices a figure emerge from behind the dumpster and proceed toward her which makes her instinctively lock her door. She notices him smiling as he proceeds toward her car

which makes her think he will ask for directions. As he gets close, her chest suddenly explodes, her right eye then goes black, and she raises her left arm and feels a bullet enter her arm and proceed into her neck. She then slumps over into passenger side and pretends to be dead. The person then shoots her twice more in the back before she hears his footsteps walking away in the gravel lot. No words were exchanged and none of her expensive jewelry was removed.

4. She states that she then crawled out of her car and into the kitchen entrance of [REDACTED]. Once there, the police and EMS arrive, and things go dark. She states that she was certain she would die. She provided the following description of the male: White, Italian looking, widow peak, heart shaped chin, blue eyes, nose that rounded down, black curly hair, medium build and wearing a black leather jacket. She states she was in Jacoby Hospital from April 9 until May 25 and upon discharge, went directly to airport to fly to the UK. She states that during this time, she would rarely go outside and was afraid to walk in front of windows. She lived in a constant state of fear and suffered greatly from PTSD. She states that in 1977, she became aware of the [REDACTED] pattern and was immediately struck by the similarities to her case. She states she was dismayed by the "terrible" sketches which made her question if the same person shot her. She states she is unaware if she saw a picture of [REDACTED] prior to his August arrest but in October of 1977 she was visited by Detective inspector Bernard Swift who showed her a photo array that was provided to him by Bronx DA Mario Merola's office. She made an immediate identification in spite of Swift's instructions to take her time. She states she was one-hundred percent certain, and that Swift told her she had identified [REDACTED]. She stated that she remained in the UK until May of 1979 and that she and Swift had often talked about how they had no further contact with investigators or the Bronx DA in regard. She states that Swift described it as "awfully rude".

 (CLOSING) CLOSING ON EXCEPTIONAL CLEARANCE

**Summary of Investigation:**

1. On May 30, 2024, at approximately 0600 hours, I am requesting this case be closed on an exceptional clearance due to Statute of Limitations. Additionally, this case is being attributed to The [REDACTED] Pattern and [REDACTED] is identified as the shooter.

2. On April 9, 1976, [REDACTED] was shot five times in the right eye, face, chest and back as she sat in her vehicle in a parking lot behind 3372 Boston Road, which was [REDACTED] Restaurant at the time. There was no obvious motive for this shooting as no property was removed, Mrs. [REDACTED] had no criminal associations, and the perpetrator did not say anything prior to the shooting. There was typical initial suspicion pertaining to her husband, [REDACTED] but nothing materialized and Mr. [REDACTED] actions in the years subsequent to the incident demonstrate a legitimate fear that the perpetrator could return to kill his wife or children. This included keeping his wife in the UK and sending his children to live in Florida under assumed names. [REDACTED] remained married to his wife until his death in 2007

3. The initial connection made between this case and an established [REDACTED] case was made on July 30, 1976. A Detective from the 9th Homicide zone and a Detective from the 47th Squad conferred regarding the similarities between the [REDACTED] / [REDACTED] (Case #1) Shooting/Homicide which had occurred three months after the [REDACTED] shooting, a mere two miles apart. This included comparisons of both MO (Shot in car / random nature) and appearance of the perp as noted in witness/victim statement and sketches. At this time, [REDACTED] was not a suspect, and the larger pattern was not yet established as the [REDACTED] /

█████ case has always been considered the first shooting. It should be noted that █████ admitted to stabbing females on two separate occasions in December of 1975 in the area surrounding Co-op City. Only one of those victims has been identified.

4. In May of 1976, after a lengthy stay in Jacobi Hospital, █████ fled to her home in England where she continued to live in fear. Sometime in 1977, she became aware of the █████ shootings as they were playing out in the media. She said immediately thought the facts of the pattern were similar enough to her case but that she was dismayed at the "terrible" sketches that were being shown in the news. In October of 1977, she was visited by Detective Inspector Bernard Swift of the █████ Police Department who was in possession of a photo array that was provided by Bronx District Attorney Mario Merola. She states that she made an identification at that time and Swift informed her that she had made an identification of █████ █████ █████ remained in England until May of 1979 and had many conversations with Swift in regard to never hearing anything further from investigators or The Bronx DA. The █████ family theorizes that this was a result of Merola and █████ █████ being political adversaries. █████ █████ tried to initiate a civil suit against █████ in 1980 but was unable to continue due to statute of limitations.

5. In the █████ pattern, all victims except █████ █████ █████ and █████ █████ were sitting in cars when they were shot. █████ was shot repeatedly with a .32 Cal Semi-auto at close range while she sat in her car but in the remainder of pattern cases, a .44 Caliber revolver was used. █████ did not purchase the .44 Caliber until June 12, 1976. It is reasonable to conclude that the .32 cal proved less than effective, hence the upgrade to the larger .44 Cal. █████ described the person that shot her as "smiling" as he approached her car, which made her feel as if he was not a threat and was about to ask for directions. Other victims and witnesses described █████ smile as he walked toward them. █████ himself stated that he used his face as weapon to disarm people before acting violently. The geography of the pattern and █████ daily travels should also be noted in regard to the █████ Case. █████ had previously lived at █████ █████ █████ which is less than a mile from the location of the █████ Shooting and in close proximity to the December 1975 Co-op City stabbings and the █████ Homicide. At the Time of the █████ case, he had been living in an apartment on █████ █████ in New Rochelle until April 8, 1976, which is the day before █████ was shot. According to his landlord, Ms. █████ █████ was acting irrationally in regard to her barking dog and had abruptly moved out citing the dogs. This negative emotional response to barking dogs is evident in at least four shootings attributed █████. This includes dated and documented writings of █████ that discuss the effects of barking dogs, which are often written the same day of or a day before a shooting. Additionally, █████ is on record as telling investigators in Brooklyn that he was involved in a shooting of an older woman who crawled away and survived. He stated this shooting occurred in Yonkers, but officials could not determine a date, victim or location.

6. The physical description provided by █████ is almost an exact match when compared to other cases in the pattern. The male white, late 20's to early 30's, 5'8", 160-180 lbs is consistent with little variation. █████ described her assailant as wearing a leather jacket. I have reviewed an interview of a former friend of █████ in which he states he had lent him a leather jacket during that period that he never received back. Additionally, the sketch provided by █████ is a mirror image of █████ when placed side to side with his mugshot.

7. On May 29, 2024, members of the Bronx Homicide conducted an interview of █████ at █████ Correctional facility. █████ denied being involved in the shooting. █████ stated that he could not have been involved in that shooting because he only used a .44 caliber in his crimes. I reminded █████ that I never mentioned the caliber used in the █████ case and that I knew that he purchased the .44 in June of 1976. He responded, "well that .44 was the only gun I used" It was later determined that █████ was aware of the █████ █████ YouTube show prior to the interview and the discussions relating to caliber. While █████ never cited this, a review of his inmate email account demonstrates that he and █████ █████ this aspect of the case in the weeks prior to the interview. Additionally, █████ stated that the sketch done by █████ █████ uncanny when compared to him and the █████ sketch; and that the MO was the same and admitted that barking dogs were a trigger for him. He described leaving the New Rochelle address the day before █████ was shot due to his negative emotional response to the landlady's barking dogs. He could not say specifically where he was living during the gap between New Rochelle and the Yonkers address but speculates that he was living in his car. Additionally, when asked if he was on a jury and presented with the facts of this case as I was presenting them, he conceded that he would find himself guilty, but continued to deny that he was involved.

8. In light of these facts, it is the opinion of the Investigators of the Bronx Homicide Squad, that probable cause has been established that █████ is responsible for the shooting of █████ █████ A conferral was made with ADA Christine Scaccia of the Bronx District Attorney's Office and she in in agreement that if the facts of this case were associated to a present-day case, an arrest would be made. Based on the Statute of Limitations for Felony Assault, this case is closed on an Exceptional Clearance.
